

# MEMORANDUM OF UNDERSTANDING (MOU) FOR ACADEMIC COOPERATION

BETWEEN

Prism Group of Institutions, Bhilai, CG

**Purpose:** The purpose of this agreement is to promote co-operation in teaching-learning, research and other student centric activities like job placements, sports etc between the Departments of the aforementioned institutions.

**Types of cooperation:** Through this memorandum, both parties affirm the value of institutional collaboration and agree to promote the following activities:

4. Student exchange initiatives between both institutions for knowledge and skill development.

6. Organizing various curricular & extra-curricular activities together.
7. Other activities of mutual interest.

This agreement places no financial obligations or supplementary funding commitments on either party.

These activities will be defined between head of departments of the institution through separate communication. Subsequent program agreements must be approved in writing by the authorized representatives of each institution.


(Rupesh Kumar Gupta, Director, Prism Group of Institutions, Bhilai, CG) will serve as the primary liaison between the two institutions to facilitate the development of future activities.

Dr.K.K.Markam, Principle Govt. shaheed gendsingh college charama, Distt-U.B.Kanker(C.G.) will serve as the primary liaison between the two institutions to facilitate the development of future activities.

**Terms:** This agreement will become effective immediately after the date of signature by both parties. It shall remain valid for a period of two (2) years from the date of the last signature, with the understanding that it may be modified by written mutual consent of both parties. This agreement may be terminated by either party with advance written notice of at least 30 days.

The agreement may be extended by written mutual consent for renewal by both parties after the mandatory period.
